## Westchester Children and Youth Will Thrive Regardless of Race and Zip Code

This is the goal that WCA's collective impact initiative, GPS4Kids, announced publicly at their celebration on August 4th, 2016, which was graciously hosted by the Women's Club of White Plains.

In addition to the overarching goal, GPS4Kids organized the top outcome categories from conversations had by stakeholders over the last 18 months. The following benchmarks under each outcome category were identified:

- Keeping Children in School
- Increasing Race Equity
- Improving Youth-Adult Relationships

At the celebratory event, stakeholders were asked to self-select membership in one of three working groups: Data & Measurement, Communications & Community Outreach, or Strategic Action Planning.

### So, What's Next?

The working groups have all met and will continue to meet and prepare a report for the larger group.

- The Data & Measurement Group will report out on indicators GPS4Kids will use moving forward, as well as the progress of the original data index to measure the success in moving towards the goal.
- The Communications & Community Outreach Group will outline a strategy to communicate GPS4Kids to the greater community, including whom to engage further.
- The Strategic Action Planning Group will continue to vet actions and outcomes, while identifying benchmarks. Additionally, GPS4Kids plans to introduce the outcome categories to the greater community.

While the presidential race has been dominating the news, we at Westchester Children's Association have been focused on the elections at all levels of government and in particular, those for the New York State Senate and Assembly.

Being an informed voter, especially about where candidates stand on a range of issues that impact children and youth in Westchester, is an essential part of being an engaged advocate. Our annual Vote for Kids candidate survey asked candidates for the New York State Senate and Assembly to share their stance on raising the age of criminal responsibility and their top budget or policy priority for children and youth. Additionally, the survey asked candidates to indicate their level of support for shifting financial resources to policies that provide support for children and families.

This year, Westchester Children's Association partnered with Nonprofit Westchester for their #914NonProfitsVote campaign. Over the summer, along with Community Votes and Community Voices Heard, WCA's Program & Policy Associate, Sarah Yergeau, trained 15 Westchester

nonprofit staff on conducting non-partisan electoral engagement and registering voters. On September 27th, WCA joined thousands of organizations across the country in National Voter Registration Day. Voter registration forms were available in our office and we encouraged everyone to check their registration status through e-mail reminders and our social media feeds.

Children, youth and families are impacted by decisions made by elected officials at all levels of government. On November 8th make sure to Vote for Kids by voting for candidates who will prioritize children and youth.

programs targeting ethnic communities,


